

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.freshdesertmarketing.com, and Fresh Desert Marketing LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Fresh Desert Marketing LLC include www.freshdesertmarketing.com and Fresh Desert Marketing. The Fresh Desert Marketing website is a Advertising/Marketing site. By using the Fresh Desert Marketing website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Fresh Desert Marketing may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

If you purchase Fresh Desert Marketing's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Use of your Personal Information

Sharing Information with Third Parties

Fresh Desert Marketing does not sell, rent or lease its customer lists to third parties.

Automatically Collected Information

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Comply with an existing legal obligation; or
